






FIG. 1 FORWARD CURRENT DERATING CURVE




FIG. 3 TYPICAL JUNCTION CHATACTERISTIC




Fig.5 Operating Temperature Derating Curve




FIG. 2 TYPICAL REVERSE CHARACTERISTIC





FIG. 4 TYPICAL INSTANTANEOUS FORWARD CHARACTERISTICS
