


**On-Resistance vs. Drain Current** 




**Gate Charge**


Source Drain Diode Forward Voltage




**Threshold Voltage** 




**On-Resistance vs. Gate-to Source Voltage** 







Safe Operating Area




Normalized Thermal Transient Impedance, Junction-to-Ambient






