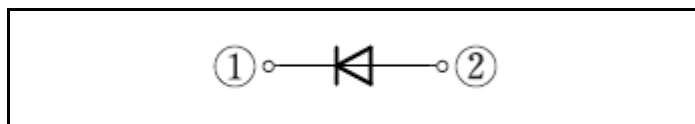

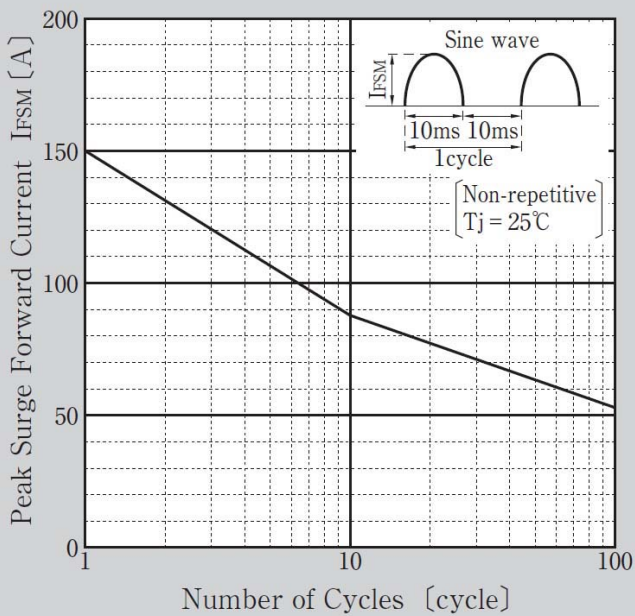
### Forward Voltage



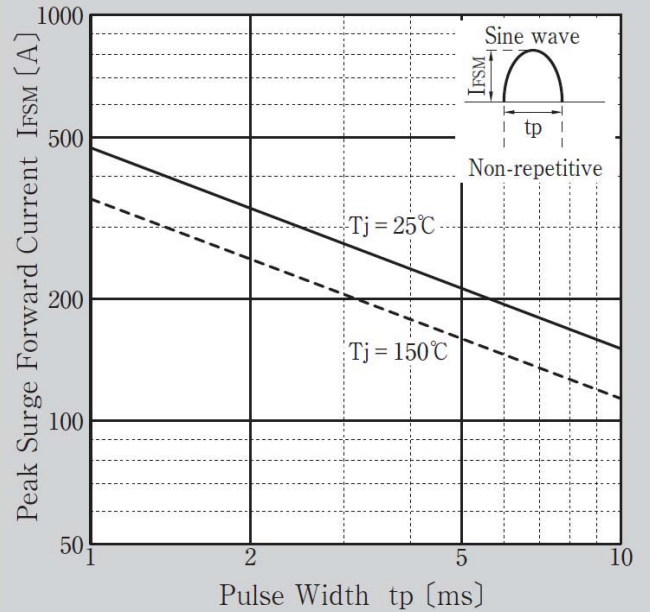
### Forward Power Dissipation

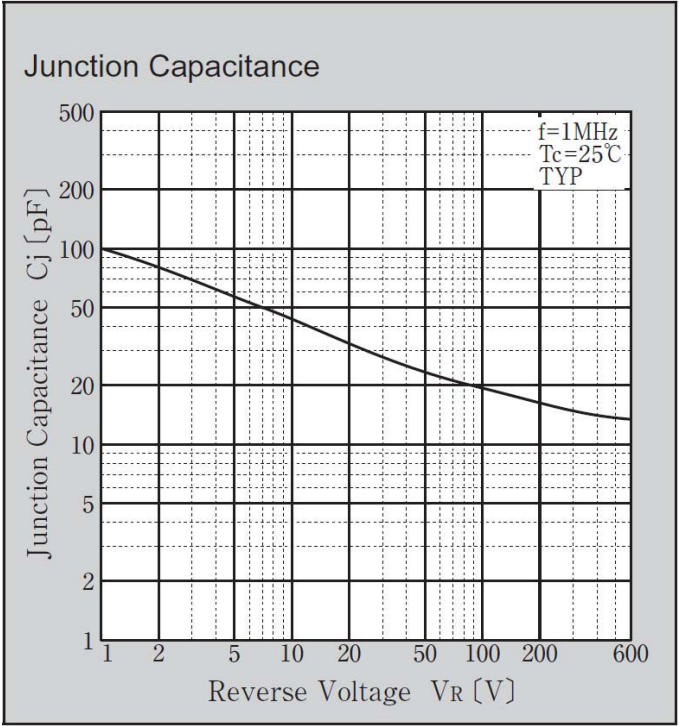
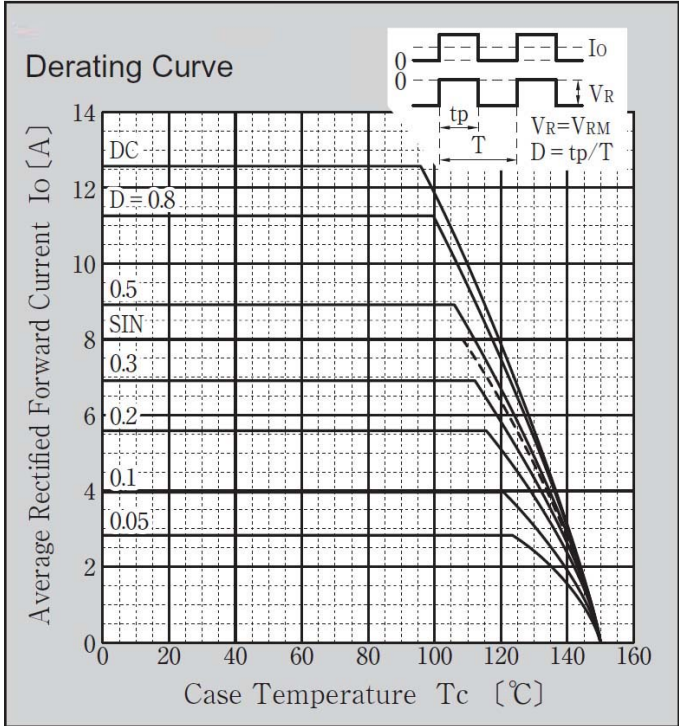


### Peak Surge Forward Current Capability



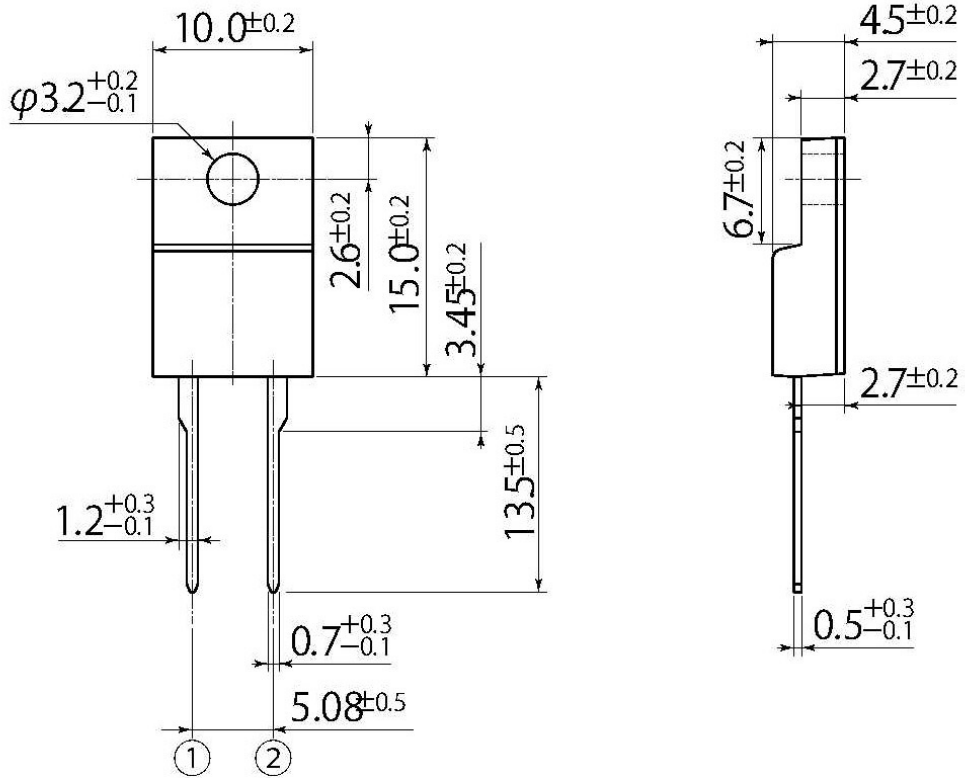
### Peak Surge Forward Current Capability
